Here is an activity the whole family can do together!


No Mess Finger Painting

Materials: 1 gallon sized sealable plastic bag Strong tape, such as painter's tape White paper, such as cardstock or printer paper Washable finger paint or food coloring and water

Take the sheet of paper and carefully squirt some drops of paint onto it. (But not too much!) You can start with one, or have your child choose which colors they would like. Place the drops on different parts of the paper, but take care to stay away from the very edges. Open up the plastic bag and slowly place the paper inside of it. Press out any excess air and seal the bag at the top so that the paint will not spill out, double-sealing it with masking tape for extra security. Place the plastic bag on a table. (Tip: You can also tape the corners of the bag to the table so that it will stay more firmly in place.) Have your child use their fingers to push and swirl the paint around through the plastic bag's surface.

Parent Tip:

As children grow, their vocabulary often has to catch up with their ability to recognize objects. They might recognize a phone, for example, but may not know how to say the word itself. This also applies to the names of colors. One way to help them is by drawing and filling in circles with different colors on pieces of paper. If a child doesn't yet recognize the name for the color "green," hold up the green circle and say, "Can you find something that is this color?"
